The percentage set forth in Row 11 of this Schedule 13G/A is calculated based upon 118,499,945 shares of Common Stock outstanding as of October 24, 2023, as reported in the Issuer's Quarterly Report on Form 10-Q for the quarterly period ended September 30, 2023 filed with the Securities and Exchange Commission on November 1, 2023, and assumes the exercise of certain warrants (the "Warrants") to purchase Common Stock of the Company held by Avoro Life Sciences Fund LLC subject to the 9.99% Blocker.

Pursuant to the terms of the Warrants, the Reporting Persons cannot exercise the Warrants to the extent the Reporting Persons would beneficially own, after any such exercise, more than 9.99% of the outstanding shares of Common Stock (the "9.99% Blocker") and the percentage set forth in Row (11) of the cover page for each Reporting Person gives effect to the 9.99% Blocker. Consequently, at this time, the Reporting Persons are not able to exercise all of such Warrants due to the 9.99% Blocker.
