HCA acts as the sole management company of Gaoling Fund, L.P. ("Gaoling") and the sole general partner of YHG Investment, L.P. ("YHG"). HCA is hereby deemed to be the beneficial owner of, and to control the voting and investment power of, shares of Common Stock (as defined in Item 2(d) below) held by the Gaoling and YHG. HCM acts as the sole management company of Hillhouse WHP Holdings Limited ("WHP"). HCM is hereby deemed to be the beneficial owner of, and to control the voting power of, the Common Stock held by WHP. HCA and HCM are under common control and share certain policies, personnel and resources. Accordingly, each of HCA and HCM reports on this Schedule 13G that it has shared voting and dispositive power of the Common Stock beneficially owned by each of HCA and HCM. HCA and HCM previously filed separate Schedules 13G with respect to the Company. They have determined to file jointly going forward.
